

OFFICIAL RULES OF THE TICKETMASTER® NHL TICKET EXCHANGE™ PUCK DROP SWEEPSTAKES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The Ticketmaster® NHL Ticket Exchange™ Puck Drop Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America or Canada (except Quebec), who are at least eighteen (18) years of age, and who have a valid Facebook account at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Timing: The Promotion period begins at 12:00 PM Pacific Time on October 8, 2014 and ends at 12:00 PM Pacific Time on October 24, 2014 ("Promotion Period"). Administrator's clock is the official time keeping device of the Promotion.

Winners agree to accept the prize "as is", and entrants hereby acknowledge that Promotion Entities and NHL Entities have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to the prize, including express warranties (if any) provided exclusively by a prize supplier that are sent along with the prize. Any valuation of the prize(s) stated above is based on available information provided to Administrator and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes. Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Promotion Entities reserve the right to seek damages from any such person to the fullest extent permitted by law.
